INTERGOVERNMENTAL AGREEMENT

This Agreement (the "2023-2027 Agreement" or "this Agreement") is entered into by and between:

LINCOLN PARISH POLICE JURY (the "Police Jury"), a political subdivision of the State of Louisiana, whose address is Post Office Box 979, Ruston, Louisiana 71273 appearing herein by and through Richard I. Durrett, its duly authorized President, and

LINCOLN PARISH FIRE DEPARTMENT, FIRE PROTECTION DISTRICT NO. 1 (hereinafter "LPFD"), a Louisiana governmental entity, whose address is 4786 Highway 167, Dubach, Louisiana 71235, appearing herein by and through Richard Aillet, chairman of the LPFD Board

(individually a "Party" and collectively the "Parties").

WHEREAS, pursuant to discussions between the LPFD and the Police Jury, the Police Jury and the LPFD have agreed to enter into this 2023-2027 Agreement for a term of five (5) years, effective and beginning January 1, 2023, in which the LPFD agrees to provide rescue services from January 1, 2023, through December 31, 2027, in the unincorporated portions of Lincoln Parish, and the Police Jury will pay to the LPFD the following sums for such services, with each payment due and payable by January 31 of each year of the agreement: Year 1 - \$478,000.00. Year 2 - \$815,000.00. Year 3 - \$691,000.00. Year 4 - \$625,000.00. Year 5 - \$625,000.00.

WHEREAS, in the event staffing and apparatus are not available to respond to an incident in the Parish involving Rescue Services from January 1, 2023, through December 31, 2027, available resources will be provided through mutual aid agreements; and,

NOW THEREFORE, for the mutual benefits of the Parties and the citizens of Lincoln Parish, the Police Jury and the LPFD agree as follows:

1. The LPFD will provide Rescue Services for a term of five (5) years, effective and beginning January 1, 2023, through December 31, 2027, in the unincorporated portions of Lincoln Parish, for the following amounts, with

each payment due and payable by January 31 of each year of the agreement: Year 1 - \$478,000.00; Year 2 - \$815,000.00; Year 3 - \$691,000.00; Year 4 - \$625,000.00; and Year 5 - \$625,000.00.

- 2. In the event staffing and apparatus are not available to respond to an incident in the Parish involving Rescue Services from January 1, 2023, through December 31, 2027, available resources will be provided through mutual aid agreements.
- 3. The term of this 2023-2027 Agreement is for a period of five (5) years, effective and beginning January 1, 2023, and ending December 31, 2027.
